Mayor Yates asked about more flock cameras being placed in town. Chief Stanley replied that the department had two license plate reading cameras and he had working on placements.

- No new information had been received on moving into the new municipal building. Dickenson County has a meeting with the Corp of Engineers on Thursday and the County Administrator is going to ask questions on behalf of the town. Attorney Josh Evans said he would ask to join their meeting.
- The Town Christmas Dinner was excellent and the Mayor thanked everyone for their attendance. Council Member Debbie Wood complimented the food of the event.
- Attorney Josh Evans continues to work on the Stone Mountain Clinic property transfer.
- The Mayor has been working with Matt Owens to relocate the gym in town limits.

Council Member Debbie Wood asked if the current town hall would be demolished. Mayor Yates answered yes.
